REQUEST FOR PROPOSALS LAWN MAINTENANCE SERVICES – 2024

The Redevelopment Authority of the City of Erie (RACE) is accepting proposals from qualified contractors to provide regular lawn maintenance services at Authority-owned properties for the 2024 mowing season. Proposals should be prepared using the forms provided and submitted to the Authority's offices (626 State St., Room 107, Erie, PA 16501 or fax to 814.870.1331) by 12:00 pm (noon) on Friday, April 19, 2024.

SCOPE OF WORK

The Contractor shall, upon authorization to proceed from RACE (typically bi-weekly with the exception of July & August every 3 weeks), provide the following services:

<u>Site Preparation</u>- Pick up and dispose of light trash such as bottles, cans, papers, small to medium tree branches, and brush. Large items to be placed at the front of the lot for pick up.

<u>Mowing</u> - Mow grass on entire parcel to a maximum height of 4". Mowing shall include areas between the street and sidewalk.

<u>Trimming</u> - Trim around all structures and features on the parcels, including houses, garages, trees, stumps, etc.

ESTIMATED QUANTITIES

The Redevelopment Authority currently owns and maintains approximately 80 properties. The actual inventory of properties to be maintained is subject to change based on on-going real property acquisition and disposition activities. Bidders shall develop a lump sum cost, per mowing event. RACE will calculate an average price per lot which will be used to adjust the total amount due for future property acquisitions and dispositions.

CONTRACTOR REQUIREMENTS

Contractor shall supply all equipment and supplies necessary to provide the required services.

Contractor shall take all necessary measures to prevent damage to the serviced property and all adjacent areas (neighboring properties, public streets).

Invoices shall be generated per mowing event and include a list of the properties serviced and the date the work was performed.

Contractor shall maintain adequate insurance coverage including General Liability, Auto, and Worker's Compensation. Prior to beginning work, Contractor shall submit a Certificate of Insurance evidencing minimum \$1,000,000 coverage and specifically naming the Erie Redevelopment Authority as a Certificate Holder.

Contractor shall be in good standing with the City of Erie, Commonwealth of Pennsylvania, and all applicable federal agencies, particularly the US Department of Housing and Urban Development.
